2 Corinthians 9:10, NIV



## Why you should make a Will



Although you may have made your intentions known to those around you, leaving a properly drafted Will ensures that your wishes can be carried out promptly and exactly as you would want.

Those people you love, including those outside your immediate family, will be cared for and you can choose to support organisations you supported in your lifetime.

If you were to die without a Will, it is not always straightforward to settle your affairs – what you leave behind will be disposed of according to intestacy laws irrespective of your wishes, and your family might be left in financial uncertainty for some time.

Having a Will can put your mind at ease, knowing that your final wishes will be respected and granted.

## Practical steps to leaving a legacy

Once you have decided to make a Will, it's a good idea to think about what you want included in it, before you consult a solicitor or put pen to paper. This should help reduce the costs involved.

#### Things you might consider include:

- How much money and what property and possessions you have
- Who you want to benefit from your Will both people and organisations
- Who should look after any children under 18 years of age
- Who is going to sort out your estate and carry out your wishes after your death – that is, who will be your executor
- The full name and address of any charity to which you wish to leave a gift

It may be helpful to make a list of what you own, including any house or flat, car, jewellery, insurance policies, savings and so on with rough values, as well as a list of liabilities, such as a mortgage, loans or credit cards, and a corresponding list of those gifts you would like to make.

#### There are several different types of gift you can make:

**A pecuniary legacy** - The most common gift is to leave a fixed sum of money (e.g. £1,000). Its real value will decrease over time due to inflation, so it's important to review your Will regularly.

A residuary legacy - This is where you give a percentage (e.g. 10%) of what is left of your estate after other gifts. This type of gift is popular as you can take care of your loved ones first and still give a proportion of the value of your residuary estate. Its relative value won't be affected by inflation.

A specific legacy - This is a gift of a particular item of property owned by you, for example a piece of jewellery or a property.

A reversionary legacy - You can leave a gift for someone to benefit from during their lifetime, for example the use of a property. When that beneficiary dies, this gift could pass to someone else or a charity.

A contingent legacy - this is where you leave a gift to someone, say an aunt, but if that person dies before you, then you may prefer the money to revert to another beneficiary.



You can make these gifts through your Will. You will need to appoint one or more trustworthy people as executors to administer your affairs after your death. You can ask a solicitor to act as an executor and to be paid for doing so out of the proceeds of the estate.

You will need to sign your Will in front of two witnesses who must be aged over 18 and they, or their spouses, must not be named in the Will. They will then need to sign it in front of you and each other.

**SGM Lifewords** highly recommends that you use a solicitor to draw up your Will or at least that you have a solicitor check a Will that you have drawn up, to ensure that it is valid and that your wishes are clearly expressed so that they can be carried out. Your solicitor will be able to organise witnesses and will keep the original copy of your Will safe.

The cost of writing a Will can vary between solicitors and will depend on factors such as how complicated your affairs may be and the experience of the solicitor. As well as solicitors, voluntary organisations such as Citizens Advice Bureau can also help with your Will.

## **Choosing a solicitor**

## Inheritance tax

If you leave a gift to charity, this is generally deducted from the value of your estate before any Inheritance Tax liability is calculated. From 6 April 2012, anyone leaving 10% or more of their estate to a charity in their Will may have the part of their estate subject to Inheritance Tax taxed at 36%, rather than 40%.

So if you leave a charitable gift, both your family and your charities can benefit. However, the rules on Inheritance Tax are complex and change from time to time. For up-to-date advice, please consult your solicitor.

## How to update or change your Will

As your circumstances change, it is important to update your Will. You can make minor changes in your Will by using a Codicil which is witnessed and signed in the same way as a Will.

**SGM Lifewords** can supply some suggested examples for you to discuss with your solicitor. Remember your codicil must be compatible with your Will so your solicitor will need to see both.

## Checklist

Here's a reminder of the most important points you need to consider:

- 1. Prayerfully consider your plans
- 2. Draw up lists of what you have to leave and the details of who you would like to leave it to
- 3. Ask a solicitor to help you draw up a Will
- 4. Check and sign your Will, and get two people to witness your signature
- 5. Keep your Will somewhere safe or ask your solicitor to keep it
- 6. Review your Will occasionally as your circumstances change
